**1) Ordinance No. 2012-022** An Ordinance Authorizing The Purchase Of Two Vehicles For The Police Division

**3) Ordinance No. 2012-024** An Ordinance Authorizing The City Manager To Execute An Agreement With America's Decorative Concrete, LLC, And Declaring An Emergency

**Abstract**

This legislation will approve an agreement with America's Decorative Concrete, LLC to perform the 2012 Concrete Repair and Replacement Program in the amount of \$257,657.35. This year's program consists of repairs along Miller Road between Drake and Columbus, Deerfield Road between East Street and Navaho, Ridge Road between Columbus and Oak, and Roxie Court.

**4) Ordinance No. 2012-025** An Ordinance Approving Property Owner Assessments Related To The 2012 Concrete Repair Program, And Declaring An Emergency

**Sponsor: Mr. Norris**

**Abstract**

This legislation will approve property owner assessments for the repair of deteriorated sidewalks and driveway aprons along Miller Road between Drake and Columbus, Deerfield Road between East Street and Navaho, Ridge Road between Columbus and Oak, and Roxie Court. Property owners with deteriorated concrete will be contacted by mail and be provided the option of either accepting the assessment or performing the necessary repairs by July 6, 2012.
