1) Ordinance 2016-094 An Ordinance Authorizing The City Manager To Execute A Collective Bargaining Agreement With Lebanon Professional Firefighters, Local 4796 Of The International Association Of Firefighters

2) Ordinance 2016-095 An Ordinance Authorizing The Redemption of \$5,820,000 Of Electric System Revenue Bonds, Series 2006 Of The City Of Lebanon, County of Warren, State of Ohio; Authorizing The Payment Of The Redemption Price And Related Costs; Authorizing Documents Necessary To Effectuate Such Redemption, And Declaring An Emergency
