PREVIOUS BUSINESS:

1) Ordinance 2016-094 An Ordinance Authorizing The City Manager To Execute A Collective Bargaining Agreement With Lebanon Professional Firefighters, Local 4796 Of The International Association Of Firefighters

Abstract

This legislation will approve a 3-year labor agreement with the International Association of Firefighters Local 4796 which represents the 6 full time fire officers of the Lebanon Fire Division.

1) Ordinance 2016-100 An Ordinance To Make Final Appropriations For Current Expenses And Other Expenditures Of The City Of Lebanon, State Of Ohio, During The Fiscal Year Ending December 31, 2017

2) Ordinance 2016-101 An Ordinance Authorizing The Transfers And Reimbursements Established By The 2017 Budget

This legislation will approve the inter-fund transfers contained in the Proposed 2017 Operating Budget.

3) Ordinance 2016-102 An Ordinance Amending Chapter 921 Of The Codified Ordinance Related To Indigent Burial Procedures

Sponsor: Mayor Brewer

Abstract

This legislation will approve updates to Section 921.08 of the Codified Ordinances which are the City's Indigent Burial Regulations. These updates will increase the cremation services maximum reimbursement from \$275 to \$300, and the maximum reimbursement for administration and labor charges from \$200 to \$250.

4) Resolution 2016-103 A Resolution Authorizing The City Manager To Enter Into An Agreement With The Ohio Department Of Transportation To Perform Bridge Inspection Program Services

Sponsor: Mayor Brewer

Abstract

This legislation will approve a Local Public Agency agreement with ODOT to allow ODOT to perform the required annual inspections of the City's 15 roadway bridges for a 3-year period. These services are being provided to the City at no cost.

5) Ordinance 2016-105 An Ordinance To Approve The Record Plan For The Final Plat Of Avalon Heights Section 3, And Declaring An Emergency

Abstract

This legislation will approve the re-plat of 94 Burt Rd to combine 2 lots into a single 0.2 acre lot, as recommended by the Planning Commission.
