



On 2-9-14 at approximately 1522 hrs. I responded to Rural King parking lot for a hit-skip crash report. Upon my arrival I spoke with Randall Atkins who said he had parked his vehicle in the parking lot and when he returned the front bumper had been struck and cracked. Randall said one of the store employees had witnessed the crash and took the license plate number down. The store manager had pulled up the CCTV footage and the crash was recorded on the database. The store manager showed me the footage and it showed a vehicle matching the license plate number in the lot. The driver exited his vehicle after the crash and looks at both vehicles then gets in the truck and leaves the scene. I took all of Randall's information then asked the store clerk to look at the registered owners photograph. The clerk positively identified the RO's photo to the driver. I called the Warren county communication center and had Morrow PD check the residence listed on the plate information. The registered owner, Danny Bryant, called the police department shortly after. I explained the situation to Danny and he admitted the crash over the phone. On 2-10-14 Danny Bryant came to the police department where he was issued a citation for leaving the scene of the crash. Danny admitted he was driving, looked at the damage and left. I showed Danny the CCTV footage and he said it was him in the video. Danny said he did not see any damage to the vehicle. I told Danny the damage was to the front of the vehicle right where he had struck it and the damage was noticeable. Danny provided his operators license and proof of insurance. I explained the citation to Danny and asked if he had any questions. Danny said he was scheduled to be out of town this up coming week so I set his mandatory court appearance for 2-24-14. Danny signed his citation. This incident happened in the city of Lebanon in Warren county.
