AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH DAILY'S LAWN AND LANDSCAPING

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Lebanon, Ohio:

SECTION 1. That the City Manager be authorized and directed to execute a 2-year Agreement, with a City-option for a 3rd year at the same contract cost, between the City of Lebanon and Daily's Lawn and Landscaping in the amount of \$61,278.09 to provide City facilities mowing and landscaping services as outlined in Contract B of the City of Lebanon Mowing, Landscaping, and Maintenance Annual Contract, in substantially the same form as the contract specifications on file with the City of Lebanon.

SECTION 2. This Ordinance is necessary for the preservation of the public peace, health, safety, morals and welfare of the City of Lebanon and shall take effect at the earliest period allowed by law.

THIS AGREEMENT, made this day of Mach, 2019, by and between the City of Lebanon, an Ohio municipal corporation, hereinafter called "CITY" and Daily's Lawn and Landscaping, doing business as an individual in the State of Ohio herein- after called "CONTRACTOR".

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned to be made and performed by the City, the Contractor hereby agrees to furnish all labor, material, tools and equipment necessary for the entire work as set forth in the Contract Documents and Specifications which are incorporated herein by reference and entitled:

BUSH HOGGING & FINISHED MOWING OF RIGHT OF WAY & VARIOUS PARCELS OF THE CITY OF LEBANON CONTRACT A – CONTRACT B OR BOTH

including all pertinent work listed or implied in said specifications. The City shall pay the Contractor a monthly cost for all mowing's completed for the month which will be pro-rated from the annual lump sum prices stipulated in the Bid Proposal and Bid Schedules for either Contract A Bush Hogging or Contract B Finished Mowing & Landscaping or Both Contracts A & B which shall be deemed full compensation for furnishing the provided services with the understanding the total amount of all monthly invoices at the end of the contract date will not be greater than the annual lump sum prices provided in the Bid Schedule, unless approved in writing by the City.
